**By Signing this Promissory Note Agreement I understand and agree to the following:**

- 1) I promise to pay Florida Gulf Coast University (FGCU) the agreed upon amount by the published or assigned due date OR immediately upon withdrawal from FGCU OR immediately upon receipt of any monies through the University or other educational lenders OR the last day of the semester, whichever occurs first.
- 2) This promissory note agreement is for tuition & fees only and does not include any non-tuition associated costs such as book charges, meal plan charges or housing charges.
- 3) When I register for any class at FGCU or receive any service from FGCU I accept full responsibility to pay all tuition, fees and other associated costs assessed as a result of my registration and/or receipt of services. I further understand and agree that my registration and acceptance of these terms constitutes a promissory note agreement (i.e., a financial obligation in the form of an educational loan as defined by the U.S. Bankruptcy Code at 11 U.S.C. §523(a)(8)) in which FGCU is providing me educational services, deferring some or all of my payment obligation for those services, and I promise to pay for all assessed tuition, fees and other associated costs by the published or assigned due date.
- 4) If my account becomes delinquent I will not be allowed to make any registration changes for the current semester, register for classes for the next semester, certify registration, view grades, and obtain transcripts or a diploma.
- 5) If I fail to pay my student account bill or any monies due and owing FGCU by the published or assigned due date, FGCU will assess a late payment fee of \$100.00 to my account.
- 6) I am not eligible to receive a Veteran tuition deferment for the current term or any future terms if my account is not in good financial standing with FGCU.
- 7) If my account becomes delinquent 180 days past the published or assigned due date I am responsible for the fees, including a collection fee which is calculated based on the balance I owe to FGCU and cannot exceed 33 1/3 % of the amount placed with the University's collection agent, as well as all other costs and expenses, including reasonable attorney's fees, that are incurred in such collection efforts.
